1. I/we warrant:

- a. I am/we are the only author(s) of the Article;
- b. the Article is an original work and does not infringe the copyright or other rights, including moral rights, of any person;
- c. if any person who is not an author of the Article has made a substantial contribution to the Article in any way, he or she is acknowledged in the Article;
- d. as at the date of signing this form, I/we own all intellectual property rights in the Article;
- e. the Article is accurate and complete, and is not deceptive or misleading; and
- f. as at the date of signing this form, the Article has not been published anywhere in any form, and I/we have not submitted the Article, or anything substantially similar to the Article, for publication elsewhere.

2. If the Article is accepted for publication in “Communicable Diseases Intelligence”, then from the date of that acceptance I/we assign to the Commonwealth all copyright throughout the world in the Article, without limitation. I/we understand this means that from that date I/we will no longer own any copyright in the Article, and the Commonwealth may, among other things, edit and publish the Article anywhere in any form, including electronic form and permit the use, reproduction and/or publication of the Article (or part of) by persons other than the Commonwealth, including under a Creative Commons licence.

3. If the Article is accepted for publication in “Communicable Diseases Intelligence”, the Commonwealth in return grants to the author(s) of the Article a permanent, irrevocable, royalty-free, non-exclusive licence to use, reproduce, adapt and exploit the Article anywhere in the world.

4. I/we acknowledge that section 177 of the *Copyright Act 1968* has been brought to my/our attention.¹

5. If the Article is not accepted for publication, I/we authorise that the Commonwealth may keep a file copy for reference.

6. I/we agree to do whatever the Commonwealth reasonably requires to give effect to the warranties, assignment, acknowledgment and authorisations in this form, including to sign, execute or otherwise deal with any document.

Australian Privacy Principle 5 Notification

Your personal information is protected by law, including the *Privacy Act 1988* and the Australian Privacy Principles (APPs), and is being collected by the Australian Government Department of Health ('Department') for the purposes of allowing us to publish your Article in the journal "Communicable Diseases Intelligence".

If you do not provide this information, the Department will not be able to publish your Article.

The Department will disclose your name, the name of your university and your Article to Crossref, Portico and PubMed in the United States of America to facilitate the cross referencing of your Article.

Ordinarily the Department is required to comply with APP 8.1 by taking reasonable steps to ensure that overseas recipients of personal information, such as Crossref, Portico and PubMed, do not breach the APPs. However, the Department will not be required to comply with APP 8.1 if you consent to the Department's disclosure of your personal information to Crossref, Portico and PubMed. This means the Department will not be responsible if those overseas recipients do an act that would otherwise breach the APPs.
